RELEASE AGREEMENT PLEASE READ CAREFULLY BEFORE SIGNING

1. I accept for use as is the equipment listed on this form, and accept full responsibility for the care of the equipment while it is in my possession. 2. I will be responsible for the replacement at full retail value of any equipment rented under this form, but not returned to, the shop. 3. I agree to hold harmless and indemnify the ski shop and its owners, agents and employees for any loss or damage, including any that results from claims for personal injury or property damage related to the use of this equipment, except reasonable wear and tear. 4. I agree to return all rental equipment by the agreed date in clean condition to avoid any additional charges. 5. I understand that there are inherent and other risks involved in the sport for which this equipment is to be used, skiing or snowboarding, that injuries are a common and ordinary occurrence of the sport, and I freely assume those risks. 6. I understand that the ski-boot-binding system will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and is therefore no guarantee for my safety. 7. I hereby release the ski shop and its owners, agents and employees, as well as the manufacturers and distributors of this equipment from any and all liability for damage and injury to myself or to any person or property resulting from negligence, installation, maintenance, the selection, adjustment and use of this equipment, accepting myself the full responsibility for any and all such damage or injury which may result. 8. I have made no misrepresentations to the ski shop in regard to my height, weight, age or skier type. 9. I verify that the visual indicators on my bindings correspond to the settings as shown on this rental agreement form. 10. All instructions on the use of my rental equipment have been made clear to me, and I understand the function of my equipment. 11. I accept my responsibility to ski safely at all times, to abide by the Skier Responsibility Code, and to obey all posted behavior notices and other ski area rules and policies. Any equipment I use while skiing, I use at my own risk. 12. If I am signing on behalf of a minor, I recognize that I may not release any claims the minor may have. However, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in or travel to and from 49° NORTH. I also agree to HOLD HARMLESS and INDEMNIFY CMR LANDS, LLC, CMR OPS, LLC, CMR F&B, LLC, 49° NORTH Wintersports Foundation, and all successor entities or successors in interest (including, but not limited to, individuals, partnerships, LLCs, corporations, ect.) their agents, officers, directors, managers, members, owners, contractors, volunteers, employees and insurers, 49° NORTH Rental Shop, the manufacturers and distributors of the equipment, and the 49° NORTH Ski School for claims brought by or on behalf of the minor.

RELEASE FROM LIABILITY

2. I understand and accept that the use of 49° North Mountain Resort facilities, including but not limited to skiing, snowboarding, snowshoeing, the use of aerial and surface lifts, use of equipment, and other facilities including buildings, decks, walkways, and parking lots, is HAZARDOUS. Falls and injuries are a common occurrence and you must keep deliberate and conscious control of your physical body, both on the ground and in the air, while properly using your equipment in variable weather and other conditions. Ski, snowboard, and snowshoe only within your ability. Safety is directly affected by your judgment in the severe elements of rough, high mountain terrain. Be alert to all risks, hazards and dangers, including but not limited to: Variations in weather, in-bounds avalanches, deep snow immersion and suffocation, variations in terrain (including terrain features, steepness and other variations, whether natural or as a result of slope design or grooming), surface or subsurface snow or ice conditions whether natural or machine-made, bare spots, rocks, trees, stumps, and other forms of forest growth or debris, lift towers and components thereof, other ski area components including lights, fences, posts, and signs, all of the foregoing whether above or below the snow surface; pole lines, snowmaking equipment, and other equipment, vehicles and machines including snowmobiles and snowcats; collision with any person, vehicle or object whether natural or man-made.

For valuable consideration received, I grant CMR OPS and its agents, ("Photographer") and his/her legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of myself and the minor child named above, for editorial, trade, advertising, without my inspection or approval. I hereby release Photographer and his/her legal representatives and assigns from all claims and liability relating to said photographs.
